

Proposed Minutes of May 14, 2018

The Ossineke Township Board met in Regular Session, at the Ossineke Twp. Hall. Supervisor Lobert called the meeting to order, at 7:00 p.m. The Pledge of Allegiance was recited. The minutes of April 9, 2018 were approved as corrected.

The Treasurer reported balances on hand as of May 1, 2018 as follows:

\$1,815.20 in the Trust and Agency

CITIZENS:

Dennis Meggert came to the board with concerns regarding the road he lives on. He would like to see it gravelled and if gravel is not an option at this time, than to have it graded more often. Dennis also asked about having all his properties homesteaded. They are all connecting pieces. Supervisor Lobert believes that they are already on one homestead and he will look into it.

ZONING ENFORCEMENT OFFICER:

1 zoning permit issued to Bruce Schaefer on Beaver Lake Rd for a 40X60 Pole Barn. Randy had a blight complaint that was taken to the Health Department, Kevin Prevost inspected the property and it was agreed that it was an environmental concern and not a zoning issue. It needs to be settled between the owner and the lien holder.
