AUDIT:

Supervisor Lobert discussed his Assessing audit that was conducted by Tax management for the State of Michigan. He was informed of 2 findings and is making the necessary

corrections to be compliant.

Ossineke Township was also audited by the Michigan Participating Plan. Recommendations/suggestions from the audit were to have an Attorney review all legal contracts, hand out sexual discrimination pamphlets for all new employees, and to post occupational safety postings on the walls at the halls.

RESOLUTION 2018-5:

A Resolution to Renew Fire Protection, Rescue, and Fire Equipment Millage.

Whereas, Ossineke Township provides contractual fire, rescue and other emergency services to our residents, visitors, and

Whereas, Ossineke Township shares the cost of new purchases of fire and rescue equipment with other townships, and

Whereas, one mill tax levy for the purpose of the fire equipment, paying contractual costs of fire protection, including training and medical first response services; and, establishing a reserve for the future purchase of fire equipment did expire at the end of 2017.

Now Therefore Be It Resolved, that the Ossineke Township Board of Trustees supports placing a five year millage renewal, for 1 mill for the Fire Department Equipment and Medical First Response Services, on November 6, 2018 Election Ballot, and

Be it Further Resolved, that the Ossineke Township Board of Trustees further recommends to its electoral members that they support the aforementioned proposal.
