

**Proposed Minutes of August 16, 2021**

The Ossineke Township Board met in Regular Session, at the Ossineke Twp. Hall. Supervisor Lobert called the meeting to order, at 7:00 p.m. The Pledge of Allegiance was recited. Board Members present were: Supervisor Kenneth Lobert, Clerk Jo'Lee S Dorie, Treasurer Denise Schultz, Trustee Jerry Leschinger and Trustee Randy Fairbanks. Also present were Kevin Grulke, Harry Krentz, Vic Patzer, LeeAnn Kubbe, Dan Kubbe and Caroline Siegert.

The minutes of July 12, 2021, were approved as read.

**CITIZENS:**

Vic Patzer brought concerns to the board regarding semi-trucks driving fast on Hubbard Lake Road. Supervisor Lobert will investigate what can be done and discuss with Road Commission. Caroline Siegert has concerns with people driving thru the stop sign at Hubbard Lake Road and Nicholson Hill Road.

**LIQUOR INSPECTIONS:**

May, June and July 2021 liquor inspection forms reviewed and filed.

**ZONING:**

2 zoning permits issued. Randy talked with Al Gonzler, with the Hubbard Lake Beautification Association and they would like to put a "Welcome to Hubbard Lake" sign up on Hubert Rd. Schultz moved, Dorie supported, **CARRIED**, to allow the Hubbard Lake Beautification Association to erect the sign. Randy received a complaint about 20-30 cats at a home on 1st Street in Hubbard Lake. Randy inspected the property and contacted the Sheriff's Department and Animal Control. Tim Gulden mailed a blight letter to the property owner early August. Randy received a complaint on Lakeshore Dr. regarding an RV trailer and plow truck in the yard. Randy stated he did not see an issue and informed the property owner that made the complaint. Randy gave the board an update on the Kleva farm and he is working with the owners to get it cleaned up. Randy informed the board that a civil infraction has been issued to Robert Stone and the next steps will be a court date.

**TOWNSHIP MEETING:**


